ORDINANCE NO. 1170 OF 2025

AN ORDINANCE OF THE BOROUGH OF MEDIA, COUNTY OF DELAWARE, COMMONWEALTH OF PENNSYLVANIA, AMENDING (A) SECTION 291-68 OF THE BOROUGH OF MEDIA ORDINANCES (SCHEDULE XV - HANDICAP PARKING) TO (i) ADD A HANDICAPPED PARKING SPACE AT 203 HALDEMAN STREET, 508 N. JACKSON STREET, AND 115 E. FOURTH STREET; AND (ii) REMOVE HANDICAPPED PARKING SPACES AT 111 W. FRANKLIN STREET AND 402 N. OLIVE STREET; AND (B) SECTION 291-60 OF THE BOROUGH OF MEDIA ORDINANCES (SCHEDULE VII - STOP INTERSECTIONS) TO INSTALL STOP SIGNS AT THE NORTH AND SOUTH CORNERS OF THE INTERSECTION OF LEMON AND FOURTH STREETS

BE IT ORDAINED AND ENACTED, by the Borough Council of the Borough of Media as follows:

Section 1: Amendment of § 291-68. Schedule XV: Handicap Parking.

(a) § 291-68 of the Code of the Borough of Media, entitled “Schedule XV: Handicap Parking,” is hereby amended by adding the following locations:

203 Haldeman Street	1
508 N. Jackson Street	1
115 E. Fourth Street	1

(b) § 291-68 of the Code of the Borough of Media, entitled “Schedule XV: Handicap Parking,” is hereby amended by removing the following locations:

<i>Street Address</i>	<i>Number of Spaces</i>
111 W. Franklin Street	1
402 N. Olive Street	1

Section 2: Amendment of § 291-60. Schedule VII: Stop Intersections. § 291-60 of the Code of the Borough of Media, entitled “Schedule VII: Stop Intersections,” is hereby amended by adding the following locations:

<i>Stop Sign on</i>	<i>Direction of Travel</i>	<i>At Intersection of</i>
Lemon Street	North	Fourth Street
Lemon Street	South	Fourth Street

Section 3: Severability: The provisions of this Ordinance are severable, and if any sections, sentences, clauses, parts or provisions thereof shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted as if such illegal, invalid or unconstitutional, sections, sentences, clauses, parts or provisions had not been included therein.


Section 4: Saving Provision: Nothing in this Ordinance, as hereby amended, shall be construed to affect any suit or proceeding in any Court, and rights acquired or liability incurred, any permit issued, or any cause or causes of action existing under this Ordinance prior to the adoption of this amendment.

Section 5: Immediate Effect: This Ordinance shall take effect and be in force from and after its approval of this amendment.


